

Subject: Disclosure pursuant to art. 13 of Legislative Decree 196/2003 and art. 13 of Regulation (EU) 2016/679

According to the art. 13 of Legislative Decree 196/2003 (hereinafter "Privacy Code") and art. 13 of Regulation (EU) 2016/679 (hereafter "GDPR 2016/679"), containing provisions to protect people and other subjects regarding the processing of personal data, we wish to inform you in compliance with the aforementioned legislation and confidentiality obligations of which the undersigned Company is held.

Purpose and nature of the processing

The personal data you provide in this contract and those of the other participants, whose transfer is mandatory, will be processed for the following purposes:

- conclude the contracts for the services of the Owner;
- fulfill the pre-contractual, contractual and tax obligations deriving from existing relationships with you;

We would like to point out that, in compliance with the principles of lawfulness, the functions of the purposes and the minimization of data, pursuant to art. 5 GDPR 2016/679, the retention period of your personal data is established for a period of time not exceeding the achievement of the purposes for which they are collected and processed and in compliance with the times prescribed by law.

SCIPIO TOURS DI VANESSA SCIPIONE reserves the right to keep your data, unless otherwise indicated, so that you can be contacted again, without prejudice to your right to protection at any time the reporting of data from our archives.

Communication and dissemination

We also inform you that the data collected will never be disclosed and will not be disclosed without your explicit consent, except for the communications necessary for the performance of the services covered by this contract and for any administrative practices required by law, which may result in the transfer of data to public bodies and private companies.

Personal data transfer

Pursuant to articles 44 and ss. of the GDPR 2016/679, in order to facilitate the completion of the necessary practices to fulfill this contract, *SCIPIO TOURS DI VANESSA SCIPIONE*, acquired your express consent for the purposes and with the methods made in this information, can transfer your personal data both in Member States of the European Union and in third countries not belonging to the European Union.

Particular categories of personal data

In order to facilitate the completion of the necessary practices to fulfill this contract, pursuant to articles 26 and 27 of the Privacy Code and articles 9 and 10 GDPR 2016/679, you could provide, to *SCIPIO TOURS DI VANESSA SCIPIONE*, data qualifiable as "particular categories of personal data" (ie those data that reveal "racial or ethnic origin, political opinions, religious beliefs or philosophical, or trade union membership genetic data, biometric data intended to uniquely identify a natural person, data relating to the health or sexual life or sexual orientation of the person "). This category of data can be processed by *SCIPIO TOURS DI VANESSA SCIPIONE* only with your consent, expressed in writing by signing this information.

Rights of the data subject

At any time, you can exercise, pursuant to art. 7 of the Privacy Code and articles 15-22 of the GDPR 2016/679, the right to:

1. request confirmation of the existence or not of your personal data;
2. obtain information on the purposes of the processing, the categories of personal data, the recipients or categories of recipients to whom the personal data have been or will be communicated and, when possible, the retention period;
3. obtain the correction and deletion of data;
4. obtain the limitation of the treatment;
5. obtain the portability of the data, ie receive them from a data controller, in a structured format, commonly used and readable by an automatic device, and transmit them to another data controller without hindrance;
6. oppose the treatment at any time and also in the case of treatment for direct marketing purposes;
7. object to an automated decision-making process relating to natural persons, including profiling.
